HOW TO CARE FOR YOUR HAIR AFTER TREATMENT:

First 72hrs(Critical Period):

- Do not wash your hair.
- Avoid getting your hair wet (rain, sweat, swimming, steam rooms, etc.).
- Do not use hair clips, ponytails, headbands, or tuck your hair behind your ears. Keep your hair as straight as possible.
- If hair accidentally gets wet: Immediately blow dry & flat iron on low to medium heat.
- Do not apply any styling products during this period.

Ongoing Care:

- Use only sulfate-free, sodium chloride-free shampoos and conditioners.
- We recommend: [Davines]:
- Wash hair 2-3 times per week or as infrequently as possible.
- Minimize heat styling. If needed, always use a heat protectant.
- Avoid salt sprays and dry shampoos with harsh chemicals.

Swimming:

- Before swimming, apply a leave-in conditioner and wear a swim cap if possible.
- Wash hair immediately after swimming in chlorine or salt water.

Additional Tips:

- Sleep on a silk or satin pillowcase to reduce friction.
- Schedule touch-ups every 3-5 months for best results.
